CORRIGENDUM

1. Page 16, Table P5, col. (1): The asterisk (\*) shown against the entry “mustard oil” in this column should appear, not against “mustard oil”, but against the next entry in the same column, namely, “*vanaspati*”. Also, the footnote to the table against the asterisk mark – “includes margarine in 1999-2000” – should read “includes margarine in 1999-2000 and 2004-05”.
2. Page 27, paragraph 3.3.0.3, lines 3-4: The words “Report No.461, which bears the same name as the present report except for the year (1999-2000)” should be replaced by “Report No.461 (*Consumption of Some Important Commodities in India, 1999-2000*)”.
3. The following 16 pages of the Detailed Tables (State-level) of Appendix A need to be replaced. These are pp. A-145 to A-156 (in Vol.I of the report) and pp. A-557 to A-560 (in Vol.II of the report). They constitute Table 2R of Appendix A for the 4 States: Andhra Pradesh, Assam and Bihar (Vol.I), and Arunachal Pradesh (Vol.II).
